# **CCTP CREDENTIALS**



## ABOUT CCTP'S BOARD

---

CCTP's board established and maintained a voluntary and comprehensive certification program through a specifically designed certification process called the Certified Counter Terrorism Practitioner. It is based on methods currently used in the governmental and private sectors that measure competency in security practices. The CCTP Board is a for profit security certification body which delivers exceptional value by acquiring the best specialists and employing the best assessment methods independently from the influence of governments, private organizations and individuals.

# WHAT IS CCTP?

---

CCTP is a **credential** which provides demonstrable proof of knowledge and expertise in terrorism prevention, detection and deterrence.

The credential will be awarded to the eligible candidates who have successfully passed the examination which assesses the knowledge of 14 main areas in the field of counterterrorism.

Developed by practitioners for practitioners, the CCTP's addresses wide range of terrorist threats such as:

- Suicide bombers
- Improvised Explosive Devices
- Vehicle Borne Improvised Explosive Devices
- Attack with Cold Weapons
- Shooting
- Parallel Attacks
- Kidnapping
- CBRN

## PREPARATION

In order to prepare for the CCTP exam, the CCTP board provides a free preparatory group study course for participants

## EXAMINATION

The second component of CCTP is the exam component. CCTP examination is a standardized test administered and scored in a consistent manner to ensure legal defensibility.

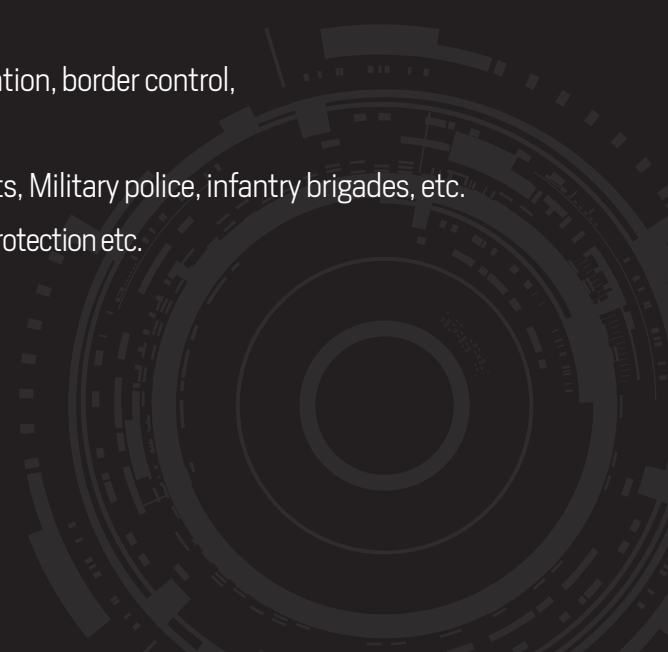
## CERTIFICATION

Candidates who successfully passed the certification examination will receive a designation certificate which is valid for three years.

# STEPS IN ORDER TO OBTAIN CCTP CERTIFICATION:

1

**APPLY** and Complete the CCTP registration form

2

**OBTAIN** the Required Experience to meet the eligibility criteria

3

**ATTEND** CCTP 3 days program- Candidates applying for the CCTP program will be required to successfully complete 28 hours of classroom instruction

4

**PASS** the CCTP exam with a minimum score of 70% - Understanding and applying the key concepts and processes of each program domain is pillar of the CCTP, candidate should pass a comprehensive examination consisting of multiple-choice questions

5

**SIGN** the CCTP code of conduct form

6

**MAINTAIN** the Certification - Maintain an active certification status by recertifying every three years.



# CCTP ELIGIBILITY

## 1. ACADEMIC AND EXPERIENCE

The participant is required to have either one of the following:

- 1.1. A minimum university degree and at least 2 years experience in the security, law enforcement or military field.
- 1.2. Relevant experience in the field of security, law enforcement or military with at least 5 years in executive or management role and/or responsibility if you do not have a relevant degree.

## 2. AGE

Minimum age of 25 years old.

## 3. DECLARATION

The participant is expected to not have any criminal records and would have to declare this status during the application process.

## 4. PROFESSIONAL REFERENCES

The participant must submit 2 professional references who have personal knowledge of and can validate your security experience, character and good standing.

## 5. COMPULSORY ATTENDANCE

The training to the 14 modules of CCTP is mandatory.

## 6. EXAMINATION

At the end of the preparatory CCTP course, the participant will be required to take an examination which will test on their understanding and application of the course work. A minimum of 70% passing mark must be achieved to qualify for the Certified Counter Terrorism Practitioner.
